**Kindly note:**

1. Amount charged for Accidental Insurance Annual Premium is fixed for AY 2023-24, charges may vary for subsequent years.
2. Hostel Room Rent has been fixed at Rs 18,400/- per semester for AY 2023-24. These charges will be revised for each Academic Year. Hostel Accommodation is compulsory for all students throughout the course duration.
3. Tentative Mess charges are Rs. 26,250/- per semester for AY 2023-24. Revised charges will be communicated to the students in due course. Also, these charges are subject to revision for each Academic Year
4. **Student Club Fee will be charged as per the approval of the Fee Approval body of the Institute and will be communicated subsequently.**
5. The Last date for fee submission is on or before: **16-07-2023**.
6. Fees must be deposited through the State Bank Collect/HDFC Smart Hub Fee Portal only.
7. **Late fee payment charges will be as follows:**
  - (i) **Rs.750/-** for delay upto **15 days**.
  - (ii) **Rs. 1,500/-** for delay upto one month; and
  - (iii) Further delay for each period up to 15 days would attract a fine of **Rs 750/-**
  - (iv) For the students who fail to deposit the Hostel and Mess charges within the stipulated time, a fine of **Rs. 100/- per day** will be charged.
  - (v) If the fee for the semester is not paid with the accrued fine upto the last day of classes for a particular semester, the student will not be allowed to appear for the end semester jury.
8. The Fee Structure is valid for Education Loan and intimation to Students/Parents.
