Kindly Note:

- Hostel Room Rent has been fixed at Rs. 20500/- per semester for AY 2025-26. These charges will be revised for each Academic Year, Hostel Accommodation is compulsory for all students throughout the course duration.
- Tentative Mess charges are Rs. 24525/- per semester for AY 2025-26. Revised charges will be communicated to the students in dues course. Also, these charges are subject to revision for each Academic Year.
- The last date for fee submission is on or before: 05<sup>th</sup> December, 2025
- Fees has to be deposited through the HDFC Smart Hub Fee Portal only.
- Late fee payment charges will be as follows:
  - Rs.750/- for delay upto 15 days.
  - Rs. 1500/- for delay upto one month; and
  - Further delay for each period upto 15 days would attract a fine of Rs. 750/-.
  - For the students who fail to deposit the Hostel and Mess dues within the stipulated time, a fine of Rs. 100/- per day will be charged.
  - If the fee for the semester is not paid with the accrued fine upto the last day of classes for a particular semester, the student will not be allowed to appear for the end semester jury.

- NOTE: 1. Hostel and mess fees is to be paid in advance before availing the facilities.  
2. Mess fee is subject to change as and when the mess contract is revised/changed.
