1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. 1. Generic

- 1. To provide comprehensive maintenance and operation of HVAC systems(VRV/VRF of Daikin m ake HVAC system with total capacity 652 HP including its all allied parts and fittings) (Refer Evaluation Schedule-2 for estimate- this item is without deployment of Technicia n for O&M on daily basis) installed at NID Haryana campus wherein the seller shall be responsi ble for regular inspection, checking, cleaning, servicing, up-keeping, maintenance and operation c omprehensively for entire HVAC system consisting Indoor units, outdoor units, ducts, piping, insul ation, hangers, HVAC dedicated electrical parts and panel of HVAC system, drains of HVAC system , Remotes, Intelligent Central Control System, Inline fans, Propeller/Exhaust Fans, Axial Flow fans and other integrated parts and fittings of HVAC system.
- 2. The scope of above works shall cover all electrical parts and accessories/ components such a s pump, compressor, Electro De-ion Module, all defective consumables/non-consumables items /spare parts etc without any extra cost and deployment of HVAC technician for operation and sh ould be capable of taking up any repair & maintenance works of his area of the system independe ntly in order to ensure to smooth functioning of HVAC system etc.

4. The sellers are advised to visit the campus and inspect the entire HVAC system and shall consider all required maintenance/replacement for smooth functioning of entire HVAC system before partici pating and quoting the price in bid process. No extra payment shall be made other than the contra ct value.

The seller should complete all pre-maintenance works, if any within 21 days from the date of awar d of work. The site can be visited upto one day before the bid closing date.

All such cost shall be considered by the seller before quoting the price. No extra payment shall be made by the buyer for pre-maintenance works

- 5. The minimum wages of state/central government (as applicable) and adopted by the institute will be payable to all employees engaged under the contract unless specified separately by the buyer. The seller shall be eligible for payment of difference amount of deployed technician -1 No. in case of increase of minimum wages by CLC, Gol.
- 6. Considering the system is of high end specialized item, only OEM and OEM authorized service providers are eligible for participating in bid.
- 7. The seller shall use only genuine OEM spare parts for repair and replacement.
- 8. The buyer if considered necessary may constitute a committee with a composition of following for conducting skill test or written test or personal interaction or Presentation or Personal Interview of manpower for selection for deployment in institute through the seller.
 - a. One Institute Representative-Admin
 - b. One Institute Representative-User
 - d. Two/One Representative of Seller
- 9. The seller shall not be allowed to remove or include any staff without prior written information wit h reasons to Institute/buyer.
- 10. In cases when the seller fails to deploy the requisite manpower within the stipulated time period, the buyer in such cases shall have the power to engage the suitable candidate and shall inform th e seller for inclusion of name of the candidate in their records for payment of salary and other for malities.
- 11. In cases when the seller fails to make payment of salary and others to the deployed staff within t he stipulated time period, the buyer shall have the power to disburse the salary directly to the depl oyed staff and recover the corresponding amount from the seller.

- 12. The Buyer shall have power to utilize the manpower for any other relevant task or post.
- 13. Wages to the workmen should be paid on or before the 7th of the subsequent month. If 7th falls on a holiday or weekly off day, the payment should be made one day prior to that. Payment of PF/ESI C/Statutory dues for the month, both the Employer's (in this case Seller) and Employee's (in this c ase workman employed by the Seller) contributions should be deposited and challan obtained bef ore the 15th of the subsequent month and forwarded to the Institute.
- 14. In case of failure of the Seller to comply with any of the above, the following action shall be take n by the Institute:

- 15. Payment Timeline: Payment shall be made on a quarterly basis within 30 days of receipt of bills s ubject to submission of all relevant documents and satisfactory completion of deployment and pa yment of all wages and statutory dues, if any.
- 16. The performance of the seller during the contract will be evaluated/reviewed after every six-mont h period. In case of unsatisfactory performance, the contract may be terminated forthwith. The de cision of the buyer/institute in the above case will be final and binding.
- 17. The seller shall not assign the contract in whole or part without obtaining the prior written consen t of the buyer.
- 18. The seller shall provide the dedicated contact No. and email Id for service support.
- 19. The duration of the service contract may be extended further up to one year beyond the initial contract duration subject to satisfactory performance and mutual consent.
- 20. The performance security deposit shall be returned after 60 days to the seller on the expiry of the contract period on furnishing usual clearance/No demand Certificate. The security deposit shall be returned on the expiry and termination of the contract subject to conditions that the seller has ind emnified the buyer for all pending dues any. The seller while requesting for release of the perform ance security deposits shall certify that all payments including Labour Laws obligations have been fulfilled and that the buyer shall not be responsible for such payments to the staff arising out of th e decision of the labour court, if any.

- 21. Buyer added specific clause/condition and scope of works will supersede the relevant clause of G EM in cases of any ambiguity.
- 22. The seller shall also comply with the scope of works (copy attached) for the services mentioned b y buyer as attachment in bid document.
- 23. Others as per service level agreements, General Terms and conditions of the contract.
- 24. If any HVAC unit is disposed during the contract period or is otherwise taken out of use, the paym ent of CAMC charges will be made only till the HVAC unit remained in use on pro-rata basis.
- 25. The seller should maintain adequate stock of spare parts for ready replacement. The seller may u se/takeaway the dead/faulty materials/parts of HVAC system. Specials Points.
- 26. The seller shall provide the free services for repair and replacement of any parts/fittings in cases of any damage happed due to physical means, natural calamities/fire, consequent effects of other systems/fittings (any things other than HVAC system) running parallel/along with HVAC system wh ich are beyond the purview/control of the system covered under CAMC. In such cases only, the buy er shall provide the materials for the same. Further, the seller shall assist the buyer in arranging su ch materials on payment basis. The buyer shall examine the damage and its cause. The decision o f buyer in such case will be final binding to the seller.
- 27. The finishing such as fading of colour, dent, scratch, rust shall not be covered under CAMC. Howe ver, the seller shall be responsible for all preventive/corrective maintenance required for up keepi ng of all system functional.

10. Service & Support
