28-07-2022


The Non-Refundable Token Fee of Rs.30,000/- paid at the time of confirming your seat will be adjusted in the fee payable for 1st Semester.

Hostel accommodation is compulsory for all students throughout the course duration. Students in the Hostel must opt for the Mess.


