Fees has to be deposited through the HDFC Smart Hub Fee Portal only. Students will receive an SMS from HDFC Bank on His/Her registered mobile number containing the deposit link which will prompt for an OTP. Thereafter fee payment can be done as per instructions from Bank.

Late fee payment charges will be as follows:

Rs. 750/- for delay upto 15 days.

Rs. 1500/- for delay upto on month; and

Further delay for each period upto 15 days would attract a fine of Rs. 750/-.

For the students who fail to deposit the Hostel and Mess dues within the stipulated time, a fine of Rs. 100/- per day will be charged.

If the fee for the semester is not paid with the accrued fine upto the last day of classes for a particular semester, the student will not be allowed to appear for the end semester jury.


\* The sum of Mess Charges are on the basis of Academic Year 2021-22. It is likely to increase and final amount will be communicated later.


