Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. The seller should complete a ll pre-maintenance works, if any within 21 days from the date of aw ard of work. The site can be visited upto one day before the bid clos ing date. All such cost including any pre-maintenance, if any shall b e considered by the seller before quoting the price. No extra payme nt other than the contract value shall be made by the buyer for premaintenance or any works
- e) The duration of the service contract may be extended further maxi mum up to five years beyond the initial contract duration subject to satisfactory performance and mutual consent.
- f) The seller shall provide the free services for repair and replacemen t of any parts/fittings in cases of any damage happened due to physical means, natural calamities/fire, consequent effects of other systems/fittings (any things other than HVAC system) running parall el/along with HVAC system which are beyond the purview/control of the system covered under CAMC. Further, the seller shall assist th e buyer in arranging such materials and payment of such materials will be done by the buyer. The buyer shall examine the damage and its cause.
