About the Institute:

The National Institutes of Design Haryana is an Institution of National Importance set up by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India, for design education, training, research and consultancy services. The Institute is located at Kurukshetra in Haryana and is offering four- year full time B.Des (Bachelor of Design) in three major disciplines of Industrial Design, Communication Design and Textiles & Apparel Design since academic year 2016-17 from its transit campus located at Umri Polytechnic, NH-44, Kurukshetra. Its own campus is under construction.

1. Controller of Finance & Accounts – 01

Applications are invited on Direct Recruitment/ Deputation basis for this post. Scale of Pay: Level-12 (Rs. 78,800-Rs. 2,09,200) of the Pay Matrix

- 1. Relaxation for eligible categories as per Govt. of India Rules.
- 2. The Institute reserves the right to relax experience in exceptional cases, or in the case of persons already holding analogous positions in an Institution of National Importance/ Centrally funded Institution / University / Research Institution.
- 3. The Institute also reserves the right to reject any or all the applications without assigning any reasons thereof.
- 4. The Institute reserves the right to offer appointment initially on contract/deputation basis/ lower position than applied for Based on the assessment of performance in Interview. They may be regularized in the post as per Institute's norms.
- 5. The Institute reserves the right to empanel candidate(s) for future vacancies.
- 6. A recognized University / Institute should have awarded Degrees etc. in support of educational qualifications.
- 7. Mere eligibility will not entitle any candidate for being called for interview. The decision of the Institute in all matters will be final.
